Medical Technology in Radiotherapy and x) bachelor of Optometry seats for Rishikesh AIIMS for the session **August, 2019** will be held on **Tuesday, the 9<sup>th</sup> July, 2019 at 9:00 a.m. sharp\*** You are, therefore, requested to report to the Academic Section AIIMS New Delhi on the above mentioned date and time along with your roll number, rank letter and original certificates. In case you are selected for admission on the basis of first counselling, you are required to appear for medical examination to be held on Monday, 29<sup>th</sup> July, 2019 at 9.00 A.M. \* Those candidates who fail to report for 1<sup>st</sup> counselling will not be considered for 2<sup>nd</sup> counselling.

The **2<sup>nd</sup> counselling** will be held on **Friday, the 26<sup>th</sup> July, 2019 at 9:00 a.m** subject to the availability of seats for **August, 2019** session. You are, therefore, requested to kindly report to the Academic Section for 2<sup>nd</sup> counselling on **Friday, the 26<sup>th</sup> July, 2019 at 9:00 a.m. sharp\***. The selected candidates during the second counselling will be medically examined on Monday 29<sup>th</sup> July, 2019 at 9:00 a.m. sharp\*. In case the selected candidate on the basis of 1<sup>st</sup> and 2<sup>nd</sup> counselling do not report for medical examination the offer made to them will be treated as cancelled/withdrawn.

The selected candidates, after they are found medically fit, are required to join immediately and no extension for joining will be entertained.

**Those candidates who have been allotted confirmed seats in the 1<sup>st</sup> counselling will not be eligible/considered for 2<sup>nd</sup> counselling.**

In each category the number of candidates called for counselling will be 8 times the number of seats. The order of counselling will be all categories. The candidates in order of merit will exercise their choice of subjects/course according to availability of seats in their respective category.

Out of the total seats (excluding AIIMS reserved seats) 27% seats are reserved for OBC candidate, 15% of seats are reserved for the Scheduled Caste candidates, 7.5% seats are reserved for Scheduled Tribe and 5% seats are reserved for PWBD candidates. In case suitable candidates belonging to Scheduled Caste and Scheduled Tribe categories are not available, the vacant seats will be filled in by the candidates from the general category.

In case any candidate is not able to appear in person on the notified date(s) for personal appearance, he/she can send his/her authorized representative with an **undertaking and authority letter for allotment** (proforma of undertaking and authority letter is given at Appendix ii and iii) along with original certificates/documents mentioned above for verification. **The allotment made to the authorized representative shall be binding on the candidate.** However, the candidates are required to join immediately after medical examination.

**Please note that if the candidate/person authorized by the candidate reports without original documents he/she will not be allowed to participate in the counseling procedure for allotment of seat.**
