On the basis of the Computer Based Test (CBT) (Stage I) held on 09.03.2019, the following is the Roll Number wise list of **Candidates** who have **Provisionally Qualified** for the Interview **(Stage-II)** for recruitment to 04 (02 UR, 01 OBC, 01 SC) posts of **Clinical Psychologist** at AIIMS, New Delhi. The Examination was conducted in accordance with the Recruitment Notice published in the Newspapers dated 2<sup>nd</sup> May, 2018 uploaded on the website on 03.05.2018 and its subsequent corrigendum uploaded on the website; and Scheme of Examination uploaded on the website on 02.03.2019.

As per Scheme of Examination uploaded on the AIIMS website on 02.03.2019, the qualifying criteria for **Stage-I** (Online (CBT) Mode Examination) and eligibility to appear in the Interview [**Stage-II**] is as follows:

- a. The candidate will have to score a minimum of 50% for UR, 45% for OBC and 40% for SC categories to qualify in the Online (CBT) Mode Examination (Stage-I) to be eligible for the Interview [Stage-II].
- **b.** The 10 times of the number of qualifying candidates against the post in each category will be called for Interview.

Accordingly, only 15 candidates are eligible to be called for the Interview [Stage-II].

The **Roll Number wise** (not merit wise) details of candidates who have provisionally qualified in **Stage-I** (Online CBT Theory Examination) and are eligible to be called for Interview **(Stage-II)** are as follows:

The Stage-II Interview of all above provisionally qualified candidates of Stage-I will be held on Tuesday, the 16<sup>th</sup> April, 2019 at Director's Committee Room, Director Office, All India Institute of Medical Sciences, Ansari Nagar, New Delhi-110608. The candidates are required to report at Dr. Ramalingaswami Board Room, Director office, AlIMS, New Delhi for verification of original documents/certificates at 8.30 A.M. sharp.

For this purpose, a separate Admit Card for Stage-II Interview will be issued and will be uploaded on the website on Monday, the 8<sup>th</sup> April, 2019. The provisionally qualified candidates of Stage (I) are advised to download their Admit Card by using their login credentials. Other than details of Venue of Interview, reporting time etc. will be available in the Admit card of Stage-II.

All the above mentioned provisionally qualified candidates are advised to reach at the Venue of Interview well before the reporting time along with all original relevant certificates/documents etc. for verification of eligibility, experience etc. for the Interview (Stage-II).



All candidates are advised to bring the following documents in original along with one set of self attested documents at the time of reporting to Interview (Stage-II) i.e. on Tuesday, the 16<sup>th</sup> April, 2019, failing which they will not be allowed to appear in the Interview in any circumstances.

- 1. Identity proof of the Candidate (In Original).
- 2. Copy of the Admit Card of Stage-I (Online (CBT) Mode) Examination.
- 3. Copy of the Admit Card of Stage-II {Interview}
- 4. All academic and experience certificates as per advertisement.
- 5. Matriculation / High School Certificate showing Date of Birth.
- 6. The candidate should bring the following certificate, if applicable:
  - a) SC Certificate issued by the competent authority (self attested) and should be in English or Hindi language. Caste/Community should be clearly mentioned in the certificate.
  - b) The Candidature of OBC (NCL) candidates shall be subject to following:-
    - (i) The certificate declaring the candidates as "OBC with Non-Creamy Layer" shall not have to be more than 6 months old.
    - (ii) The certificate has to be strictly according the format prescribed by the DOP&T vide their office Memorandum No. 36036/2/2013-Estt.(Res.) dated 30.05.2014.
    - (iii) The certificate has to clearly mention the caste/sub-caste included in the Central list of OBCs.
- 7. No Objection Certificate' if the candidate is already employed with Central / State Government / Public Undertaking.

## Important:

It may be noted that candidates are called for Interview (**Stage II**) on the basis of the information provided by them in the Registration/Application Form and the result of Stage I examination. No other screening has been performed at this stage with regard to their eligibility and any other relaxation etc. However, before Interview (Stage-II) all qualification/s, eligibility, experience and other certificates/documents will be verified/examined thoroughly by the AIIMS, New Delhi. If any candidate is found ineligible, will not be allowed to appear in the Interview (Stage-II) in any circumstances. The result and eligibility are provisional subject to fulfillment of all requirements mentioned in the advertisement and Scheme of Examination.
