The above candidates who have qualified in the Physical Standards Test (PST) (Stage-II) are eligible to appear in the Stage-III i.e. Physical Efficiency Test (PET).

The Stage-III Examinations- *Physical Efficiency Test (PST)* will be conducted on Monday, the 27<sup>th</sup> November, 2017 & Tuesday, the 28<sup>th</sup> November, 2017 as per Scheme of Examination uploaded on the website. It is expected that for each candidate the Physical Efficiency Test will be completed within one day. In case, the Physical Efficiency Test is not completed within the assigned date for the particular candidate, the test may be completed on the next day. The Candidate must therefore, be prepared to stay for an extra day following the date for Physical Efficiency Test. However, the candidate must report on the date and time mentioned in the Admit Card. No request with regard to change in date and time of the Stage-III PET test will be entertained in any circumstances.



A separate Admit card for **Stage-III** Examinations will be issued and uploaded on the website on **Monday, the 20<sup>th</sup> November, 2017** to the above mentioned provisionally successful candidates. The details of Examination Centre, reporting time etc. will be available in the Admit card. **The Admit Card for Stage-III** may be downloaded from the AIIMS Examination Section website <a href="www.aiimsexams.org">www.aiimsexams.org</a>. Only the admit card issued for Stage-III will be valid for entry into the venue of Physical Efficiency Test (PET).

All the above mentioned provisionally qualified candidates are advised to reach at the Examination Centre prior to the reporting time as mentioned in the **Stage-III Admit card**.

All candidates are advised to bring the following documents at the time of reporting to Stage-III Examination, failing which they will not be allowed to appear in the test.

1. Identity proof of the Candidate (In Original).

- 2. Copy of the Admit Card of Stage-I (Online (CBT) Mode) Examination.
- 3. Copy of the Admit Card of Stage-II [Physical Standards Test (PST)] Examination
- 4. Copy of the Admit Card of Stage-III [Physical Efficiency Test (PET)] Examination
- 5. One recent passport size photograph

## Important:

It may be noted that candidates are called for Stage III on the basis of the information provided by them in the Registration Form and the results of Stage I & Stage II examinations. No other screening has been performed at this stage with regard to their eligibility and any other relaxation. These will only be determined at time of verification of their Original documents by the Recruitment Cell, AIIMS, New Delhi after declaration of **Stage-III** Examination.

Candidates are hereby informed that they shall appear for the Physical Efficiency Test (PET) at their own risk and peril. AIIMS and CISF shall not be responsible for any consequences including bodily harm, injury or infirmity arising out of the test. Candidates must therefore, satisfy themselves that they are fit to undertake the Physical Efficiency Test (PET) as mentioned in the Scheme of Examination. Candidates who are suffering from any illness or infirmity that may result in any problems during the Physical Efficiency Test must seek appropriate medical advice before appearing for the test.

These results and eligibility are provisional subject to fulfillment of all requirements mentioned in the advertisement and Scheme of Examination. Being eligible at any of the stages is therefore subject to verification of all relevant documents at the end of Stage III, as mentioned above.
